Within Public Notice 1/2016 and Public Notice 2/2019 "targeted call" for the submission of cooperation projects with procedure "one step" to apply on priority Axes I, II, III the total number of potential beneficiaries that submitted project proposals was n. 330.

Regarding the **S.O. 1.1** total number of participant beneficiaries was of 141 entities of which 31% Universities, 23% Microenterprises and SMEs, 16% Local Administrations, 8% central/regional Administrations, 7% national\regional Research Institution and Entities, 5% Higher Training Schools, 3% State specialized Institute and Agencies; 2% Cluster/districts (productive/

technological) and 1% Chamber of Commerce, Scientific Parks, Civil and Military Authorities per each respectively.


Regarding the **S.O. 2.1** total number of participant beneficiaries was of 9 entities of which 33% Universities, 22% Microenterprises and SMEs and State specialized Institute and Agencies per each respectively and 11% Business Incubator and Scientific Parks per each respectively.

Regarding the <u>S.O. 2.2</u> total number of participant beneficiaries was of 19 entities of which 42% Higher Training Schools, 37% Microenterprises and SMEs, l'11% Chamber of Commerce and 5% for Local Administrations and Other.

Regarding the **S.O. 3.1** total number of participant beneficiaries was of 97 entities of which 32% Universities, 19% Local Administrations, 13% central/regional Administrations and national\regional Research Institution and Entities per each respectively, 9% Protected Areas Managing Entities, I'8% State specialized Institute and Agencies, 2% Trade Associations and Other per each respectively and I'1% Higher Training Schools.

Regarding the <u>S.O. 3.2</u> total number of participant beneficiaries was of 64 entities of which 44% U Universities, 27% national\regional Research Institution and Entities, 16% central/regional Administrations, 8% State specialized Institute and Agencies, 6% Local Administrations.


The hereunder graphic shows the distribution of potential beneficiary type related to Specific Objective





Graphics hereunder show the distribution of potential beneficiary type related to Specific Objective




